Until being appointed professor at the Scandinavian Institute for Maritime Law in 2021, Amund was for more than a decade a practising lawyer and partner in a leading Nordic law firm. As a counsel and arbitrator he was mainly instructed in disputed concerning oil & gas, shipping, construction, insurance, information technology, insurance and M&A, in addition to regular commercial disputes.

His practice as counsel and arbitrator included more than 50 large cases concerning Norway, the Nordics and international disputes. The international cases concerned, inter alia, UK, Germany, France, US, the Middle East and Corea. Several of the cases concerned arbitral institutions like UNCITRAL, ICC, SCC, DIA og OCC.
